OEMs Knocking on the Doors for ISO 9001 Manufacturers in North Dakota

OEMs: *Knock! Knock!*

Many small- and medium-sized manufacturers in North Dakota are seeing waves of RFQs from key OEMs looking to outsource more work to them. This wave of outsourcing is caused by OEMs gearing back up, pulling manufacturing back into the USA and/or unavailability of workers at their facilities to meet demand.

One of the keys (or barriers; depending on where your organization is at) to entry is ISO9001 Quality Management System (QMS) compliance and certification. Most OEMs demand that their risks of disruption are mitigated by their supply chain being ISO9001 Certified.
